- Annual application is required.
- Preference may be given to forestry related fields but not exclusively awarded to such candidates.

EVERGREEN Criteria

- Current resident of Western Washington. Employee of a current OLC member. Current member is defined by paid membership within the past two years.
- Pursuing post-secondary education.
- Application must be completed in full and supporting documents submitted with application.
- Annual application is required.
- Preference may be given to timber related fields but not exclusively awarded to such candidates.
